Minutes Review goals for today: - Introduce Keturah Hallmosley potential new ARC Board member - Review, Discuss, and Vote to approve 2019 ARC Budget	- Jonathan Hartung called the meeting to order at 6:07 pm - It was determined that a Quorum was present if including Keturah, Bill to present Director's report while waiting for Quorum able to vote. Quorum present when Bernardo Ruiz arrived. - Jonathan called for a motion on the Consent Agenda. Vic Roberson motioned to approve. Michael Cuadra seconded the Consent Agenda. Vote all in favor. None opposed. - Jonathan called for motion to approve the November Board Minutes. Terry Holme amended comment made during Director's Report. Frana Milan amended attendance to excused absence. Terry motioned to approve Minutes as amended. Vic seconded. Vote all in favor. 6:15 p 6:25 p	Director's Report	- Bill cited financially/revenue at the end of Nov. this year ARC is within 1% from Nov. last year - Bill spotlighted new Accounts Payable Process, NCR paper process for 40+ years, now online with Microix, all auth & approvals so much faster, added benefit in reduced travel time to community centers, even though removes interaction, it also amplifies importance of monthly AC meetings - Also mentioned accounting software now to Cloud, no longer relaying on Parks for server access - Bill highlighted payroll migration to Paycom, which includes new HRIS system and new Parks program registration software, ActiveNet, went live Nov. 27th, sustainability fee at registration - Terry asked: when the fee is taken, Bill replied: fee is taken right away, along with merchant credit card fees, there also is fee for every registration, possible \$484,000 expense for 2019 - Sharon mentioned that there are many great efficiencies within PayCom, upgraded HRIS allows easier applicant tracking & better management system, time invested in setting up/populating - Mike inquired about software issues and effect of WA state's 2019 paid family/sick leave laws - Bill stated there have been minimal software issues & laws only apply to full time employees - Lastly Bill brought up existence/importance of employee activities, i.e. the Autumn hike at Carkeek with the old orchard & the Employee Summer Picnic where 80+ people showed up
